## 23.069 Roads and Transportation

- Buckland Wharf & Tring Hill Traffic calming Truvelo Strips installed, monitoring to begin 17<sup>th</sup> April 2023 for two weeks.
- Buckland Road yellow lines had not been installed, contractors for BCC have now changed and much doubt as to whether these would now be installed.
- Bridleway Bucks Council's rights of way officer had given permission for Laxton developers to remove bollards and padlocks, allowing access from Puttenham through to Buckland. No communication had been received by the Parish Council from Bucks Council. Agreed to send email stating that canal bridge is listed (no 8 on Aylesbury arm of Grand Union Canal) and there is a 7.5tonnes weight limit on the bridge.
   Action: Clerk to send email to Buckinghamshire Council.

## 23.070 Maintenance of Land Holdings

- a. Burial Ground including Churchyard Maintenance
  - New contractors had carried out first cut of churchyard work had been very effective. Contractor requested to carry out work fortnightly @£400 per visit. Agreed to keep monthly, with extra cut prior to church celebrations in June.
- b. Community Orchard
  Number of standpipes has been increased to 6, allowing hoses to be moved around more
  easily. Water meter currently being run from nearby residents' house, investigate the
  possibility of connecting a water meter to the water main already carrying water long the road
  towards Canal Farm.

### 23.071 Footpaths, Grass verges and Environment

- a. Damage to verge by Model Row; still waiting for granite setts to be repaired, drainage channels still blocked with mud. Both Thames Water and Giglaclear have said they will repair damage to verges.
- **23.072 Thames Water pumping station –** Councillors and Thames Water had held a meeting to discuss proposed Water Pumping station in field on left across from Buckland crossroads. The pumping station is to be located beside Hope Cottages. Thames Water said that they were very much in initial planning stages and very few decisions had been made. Councillors asked for pumping station to be located away from houses and a public meeting to be held in due course. Agreed that notes of meeting would be sent to Thames water.
